- 9) The Students and/or their parents may lodge a complaint against the Institution to the Fees Regulating Authority if any Institution charge, collect or demand fees over and above the fees approved by the Fees Regulating Authority. Such complaints can be filed online through the Grievance portal of the Fees Regulating Authority. So also the complaint can be made in writing with supporting documents to the Fees Regulating Authority.
- 10) If the fees approved by the Fees Regulating Authority is not acceptable to the Unaided Institutions whose fees has been determined by the Authority, then such Institutions may file the Review Application with detail reasoning thereof in detail within 15 days from the date of communication of the fees approved by the Authority.
- 11) The Review Application filed beyond the statutory period of 15 days to be treated as barred by limitation as provided u/s 14(1)(e) of the said Act of 2015 and same shall not be entertained.
- 12) The Review Application filed without pre-payment of processing of Rs. 50,000/- per course liable to be rejected.
